## **BRIEF HISTORY OF JAGCE**

The year 1974 is a landmark period in the history of Guidance and Counselling in Jamaica. The Ministry of Education responded to the need of youth by creating posts for Guidance Counsellors in the island's secondary and tertiary institutions. At that time however, there were very few trained counsellors, so the need for the training of teachers/personnel became a priority issue. The inauguration of the then National Association of Guidance Counsellors in Education (NAGCE) began after the placement of counsellors into the institutions commenced. which was in response to the critical need for support for the growing professional group. The association then became JNAGCE which was later change by resolution in 1998, to date JAGCE.
